In continuation of the orders under reference 2nd cited, the Government of India, Ministry of Health & Family Welfare, Nirman Bhavan, New Delhi Dt. 06.03.2019 has issued recognition to "this shall be a recognized medical qualification when granted by Kaloji Narayana Rao University of Health Sciences, Warangal in respect of students being trained at Malla Reddy Medical College for Women, Hyderabad with annual intake of 150 students on or after February 2018 and as per the orders of the Vice-Chancellor, KNRUHS, Warangal vide 3rd cited and as per the Statutes on affiliation of Medical Colleges of Kaloji Narayana Rao University of Health Sciences, Warangal it is hereby certified that the application of Malla Reddy Medical College for Women, Quthubullapur, RR District has been registered with KNRUHS, Warangal and continuation of provisional affiliation is granted for MBBS Course and to make the Ist MBBS admissions with an intake of 150 seats at *Malla Reddy Medical College for Women, Quthubullapur, Ranga Reddy District* for the academic year 2020-21.

The Institution / College is fully responsible to fulfil the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of Medical Council of India.

The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.

The Management of the College shall follow the regulations made by the University/State Government and also the Graduate Medical Education Regulations 1997 of the Medical Council of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice. This order is valid for a period of one year.
