Code of ethics for Research Conduct

1. Research Integrity

Use of Plagiarism Detection Software: Mandate the use of reputable plagiarism detection software to screen all research papers, theses, dissertations, and academic submissions for originality.

Educational Outreach: Provide training and educational resources on academic integrity, proper citation practices, and the consequences of plagiarism for faculty, researchers, and students.

3. Responsible Conduct of Research

Ethical Review: Ensure that all research involving human subjects, or sensitive data undergoes ethical review and approval by appropriate Scientific Review Committee (SRC) and Institutional Ethical Committee (IEC).

Conflict of Interest: Disclose and manage conflicts of interest that could potentially influence the design, conduct, or reporting of research.
