- No student should be admitted in the above courses till the formal permission of the Medical Assessment and Rating Board (MARB).
- 3. The Private Medical College should Provide Bank Guarantee of required amount against Establishment of New course of **03 seats** in favour of National Medical Commission, New Delhi valid for three years or till the course is recognised, whichever is later, from a nationalized/ scheduled Bank as per NMC/MCI's norms.
