CONSULTANCY POLICY

1. Preamble

Consultancy is an important channel through which knowledge and expertise could flow from an Institution to businesses and other external agencies, and it can contribute to the growth, development and productive relationships with these components of society. Consultancy activity in Malla Reddy Medical College for Women (MRMCW), may be associated with contractual relationships, including research, service contracts etc. with government or non-government organization in lieu of a fee. MRDCW, therefore, encourages its faculty to engage in consultancy wherever appropriate, and in a manner that is in conformity with their service agreement with the MRMCW.

2. Purpose

This policy document is intended to lay down the norms for undertaking consultancy work and its facilitation in accordance with the MRMCW's rules and procedures.

3. Definitions and Scope

Consultancy is work of a professional nature, undertaken by members of the Institution in their field of expertise, for clients outside the institution, for which some financial return is obtained. The consultancy will produce some form of contracted output which may be partly or wholly owned by the client. It will be governed by short-term contracts while making minimal use of the College resources. It would be an additional management responsibility for MRMCW, and would involve extra work for existing Faculty & Staff. Therefore, MRMCW will charge a part of the consultancy fee from the member of the MRMCW who is engaged in consultancy. Consultancy for organizations owned by a faculty or staff or an organization in which a faculty or staff may have interest or stake are also included within the scope of this policy document.

4. The Policy

All Research and Non-research consultancies as described in this Policy are governed by the following guiding principles:

a) There should be a demonstrable benefit to MRMCW from the consultancy through income, enhanced reputation, and/or expanding the expertise of the staff member.



PLASTIC BAN POLICY

There are number of reasons for banning plastic, including, plastic waste has emerged as one of the biggest environmental concerns adversely impacting the soil, water, health and wellbeing of citizen at large, excess-consumption of plastic combined with limited waste disposal systems has become a challenge to the urban waste disposal systems, and has choked the rivers and water systems in rural areas, the time has come for a systematic campaign to reduce the usage of plastic especially the single-use plastic, the college has decided to take plastic ban as a campaign of importance to address the environmental hazards being and bring attitudinal changes that shun use of plastics, the educational institutions have the unique spread and influence to educate the students and households on the needs for avoiding usage of plastic. As per the University Grant Commission (UGC) guidelines to ban the use of plastic in Universities/educational institutions and in support of the 'Swachhata Hi Sewa' Campaign, launched by the Government of India with an aim to eliminate the use of plastic and to dispose of plastic waste. The Board of Malla Reddy Health City with the concurrence of the management and all the board members had unanimously condemned utility of plastic in and around the Health City, the boardimplements strict ban on single use plastic in its campuses, canteensand hostels with immediate effect. Towards achieving the objective, following measures will be taken to make the campus 'plastic-free' by systematically banning the use of plastic and replacing the same with suitable environment-friendly substitutes at all institutions and adoption of policies and practices towards cleaner and plastic-free campus. For this, the institution shall:

- a) Ban use of single-use plastics in campuses, canteens and hostels, etc
- b) Carry out awareness drives and sensitization workshops on the harmful impacts of singleuse plastics.
